

Privacy Policy Statement (PPS)

Statement of Policy

Lucky Vantage Limited ("Lucky Vantage") pledges to comply with the requirements of the Personal Data (Privacy) Ordinance (Cap.486) of the Laws of Hong Kong. In doing so, we will ensure compliance by our staff with the strictest standards of security and confidentiality.

When we collect personal data from individuals, we will provide them with a Personal Information Collection Statement ("PICS") on or before the collection in an appropriate format and manner.

Statement of Practice

The personal information of you (the "Data Subject") collected and held by us will only be used for all purposes relating to the Lucky Draw. Participants who have enrolled for the Phase 1 Lucky Draw or the Phase 2 Lucky Draw as Permanent Residents aged 18 or above will automatically be registered for the Lucky Draw (Grand Prize and Elderly Prizes) in respect of the Grand Prize with no additional registration required.

Consent of each Winner is deemed to have been given to the Organiser for its disclosure of the Hong Kong Identity Card number of the relevant winner to the Hong Kong Government for verifying his / her vaccination status.

Information collected during the Lucky Draw campaign may be disclosed and transferred to the data processor or other agents of the Organiser who are engaged in relation to the conducting or monitoring of the Lucky Draw for such purpose only and on a need-to-know basis, without the relevant participant's prior consent. Such information will be properly stored and encrypted, and will be destroyed 45 days after the campaign ends.

Accuracy of Information

When disclosing personal data to us, you should ensure that the data you provide is complete and accurate. If you would like to change the Data Subject's personal data, please notify us immediately of the relevant changes so that we can update our records accordingly.

Information Collected When You Visit This Site

Use of cookies

When you visit this Site, we may automatically track and collect your IP address, domain server, the type of computer and type of web browser you are using and use "cookies" to improve and update this Site.

At any time, you can choose whether to accept or deny cookies; your browser on your computer is often initially set to accept cookies. However, you can choose to deny

cookies and continue browsing this Site and/or complete the registration for the Lucky Draw on this Site.

Statistics On Visitors To This Site

When you visit this Site, we record your visit only as a 'hit' and do not collect any personal data from you. We will, however, make a record of your visit that shows only the domain name, server address, part of your e-mail address, and of the page(s) visited. We use such information only for preparing general statistics on the usage of this Site.

Personal Data Security

We will take practicable measures to safeguard data security including protection against unauthorized or accidental access, processing, erasure, loss or use. Despite our effort to protect the Data Subject's personal data, given the nature of the internet, we cannot guarantee perfect security of data transmission over it. However, once we receive your transmission, we use our best endeavours to ensure its security in our own systems. The Data Subject's personal data will only be accessed by our authorized personnel.

Disclosure of Personal Data

The personal data collected by us will not be disclosed, provided or transferred to any other party in a form that would identify the Data Subject except to the parties as set out in the PICS provided to you on or before the collection of the Data Subject's personal data. The Data Subject's personal data collected by us will not be sold to any parties.

In cases when we have reason to believe that disclosing the Data Subject's personal data is necessary to identify, contact or bring legal action to protect or defend our rights or against someone who may be violating the terms or may be causing injury to or interference with our rights or property, other users, or anyone else that could be harmed by such activities, we may disclose the Data Subject's personal data. We may also disclose to the related parties or organisations or access the Date Subject's personal data when we believe in good faith that the law requires it.

We will not use or transfer the Data Subject's personal data for direct marketing purposes.

Access and Correction of Information

If any participants of the Phase 1 Lucky Draw or the Phase 2 Lucky Draw do not wish to enter the Lucky Draw (Grand Prize and Elderly Prizes), they may send their written request to the Data Protection Officer via e-mail to enquiry@vaccinationluckydraw.hk for such withdrawal.
